# Explanatory Leaflet

NHS Licence in England  
With effect from 1 April 2006

## Introduction

CLA's licence authorises photocopying and distribution of Paper Copies and Digital Copies via the NHSnet or other secure internal email system.

## Definition of copyright material covered by the CLA licence

The CLA Licence applies only to published magazines, books, journals and other periodicals. Those published after 1956 are identified by an International Standard Book or Serial Number – ISBN/ISSN.

## Ownership of the original publication

Copies must be taken from the original published paper edition owned by your organisation. Further copies may also be taken from these copies. It is permissible under the CLA Licence to make copies from copyright fee-paid copies supplied by document supply organisations such as the British Library, as well as copies supplied by CLA licensed press cuttings services.

Copies must not substitute for the purchase of a publication or for the commissioning of an artistic work. For example, if you are producing an in-house newsletter, you should not use a scanned photograph if you would otherwise have commissioned a photographer to take a new one.

## Copying authorised by the CLA licence

You can make and distribute as many copies as you require for each particular purpose, subject to the following extent limits:

- two articles from a magazine, journal or periodical
- any number of articles in a periodical dealing with a particular theme where a substantial part of the issue is dedicated to that theme
- one entire case from a published report of judicial proceedings
- one chapter from a book
- or 5% of the publication, if greater than the above.

## Who can make and receive copies?

Copies may be made for internal NHS information purposes as follows:

### Paper Copies

All staff, general practitioners employed by or contracted to the NHS, individuals providing consultancy services to the NHS and members of the public known as 'non-executive members' who sit on a Designated Committee.



Patients and carers or guardians of patients may also be provided with a single Paper Copy in connection with their treatment and/or condition.

### Digital Copies

As above, provided that these staff and contracted individuals are permitted by the NHS to have access to the NHSnet or other internal email system via a secure login process which verifies their authority.

### Does it cover copies made away from the premises?

Yes. It covers copies made for NHS internal information purposes wherever they are made. With scanning, for example, staff working from home may have a scanner and internet connection and email a copy of an article to colleagues. However, copies can only be made from copyright materials owned by the NHS.

NHS Library staff, as NHS employees, may make copies for you pursuant to the information contained in this leaflet. The CLA Licence aims to encourage and facilitate the cross-flow of information between NHS England Trusts and Bodies holding a licence. This means that you may also request and receive, or request via NHS Library staff, a copy/copies from elsewhere within the NHS. When requesting a copy/copies through your NHS Library there is no longer any need to sign a declaration form if the copying is within licence limits.

### Which publications does the CLA licence cover?

The CLA Licence covers all magazines, books, journals, and other periodicals published in the United Kingdom, apart from those on the CLA List of Excluded Categories and Works (see below).

### Foreign publications

The photocopying part of the Licence (but not the scanning part) also covers copying of works published in the following countries:

Argentina, Australia, Austria, Belgium, Canada (including Quebec), Denmark, Finland, France, Germany, Greece, Hong Kong, Iceland, Ireland, Jamaica, Luxembourg, the Netherlands, New Zealand, Norway, Singapore, South Africa, Spain, Sweden, Switzerland and the UK.

The Licence also covers works published in the USA by publishers listed in the CLA List of Participating US Publishers. This can be found on the CLA website at [www.cla.co.uk](http://www.cla.co.uk).

### Excluded categories and excluded works

#### Excluded categories:

- printed music (including the words)
- maps, charts or books of tables
- tests or public examination papers whether published individually or in collections
- work books, work cards and assignment sheets
- privately owned documents issued for tuition purposes and limited to clientele who pay fees (except for those published by the Open University or the National Extension College)
- newspapers
- internal house journals
- any work on which the copyright owner has expressly and prominently stipulated that it may not be copied under licence from CLA.

### Excluded works:

In addition to the above, some individual works are excluded from the CLA Licence. For a list of these, please refer to the CLA List of Excluded Categories and Works located next to the copier or refer to the CLA website [www.cla.co.uk](http://www.cla.co.uk) for an up to date list.

### Does the CLA licence cover e-books and e-journals?

No. Electronic books and journals will usually be published with their own licensing terms and conditions. This also applies to works published on CD ROM or on-line.

### Limitations on the use of Digital Copies

Digital Copies may not be edited or manipulated or modified in any way (i.e. no morphing or modification, changes to shape colour or shade), except for changes necessary to enable users with a disability (such as a visual impairment) to access the work.

Individual employees may save copies of a scanned image on their own PCs or in their individual password protected area of the server, but copies may not be stored on a central server or systematically indexed with the intention of creating an electronic library or corporate information resource. Copies may not be placed on, or linked to the world wide web or any external website.

Where practicable, in all Digital Copies of artistic or literary works, the author should be identified.

### Artistic works

Your CLA Licence includes the copying of artistic works (photographs, illustrations, charts, diagrams etc) where these are contained in the publication being copied. Whenever practicable to do so, you must include the name of the artist or illustrator shown in the original publication.

### Do we have to record what's being copied?

No. The NHS Licence is a 'blanket' Licence, which means Paper Copies and Digital Copies may be made (within licence limits) without keeping records of every copy. However, to help us distribute the fees to authors and publishers, we may ask particular entities within the NHS, once a year, to provide us with an updated list of the magazines, books, journals and other periodicals it subscribes to, in the form of an information audit or other data collection exercise.
